#### 4. First-aid Measures

## Personal Protection



**RESPIRATORY PROTECTION:** A NIOSH-approved air purifying respirator with an organic vapor cartridge or canister may be necessary under certain circumstances where airborne concentrations are expected to exceed exposure limits.
