4. FIRST AID MEASURES

Description of necessary measures

Inhalation: Remove from exposure area to fresh air. Treat symptomatically and supportively. If any symptoms appear, get medical attention. **Skin contact:** Rinse affected area with mild soap and water until no evidence of product remains. Get medical attention if irritation persists. **Eye contact:** Rinse eyes with plenty of water for at least 15 minutes while holding eyelids open.
