4. First-aid Measures

FIRST AID - EYE CONTACT: Immediately flush eyes with plenty of water for at least 15 minutes holding eyelids open. Get medical attention. Do NOT allow rubbing of eyes or keeping eyes closed.

8. Exposure Controls/Personal Protection

PERSONAL PROTECTION

ENGINEERING CONTROLS: Use explosion-proof ventilation equipment.
