Section 2. Composition, information on ingredients

Physical state : Liquid.

Section 4. First aid measures

Inhalation : If inhaled, remove to fresh air.

Section 5. Fire fighting measures

Flash point : > 100°C

Fire-fighting media and instructions : Use an extinguishing agent suitable for the surrounding fire.

Dike area of fire to prevent runoff.

In a fire or if heated, a pressure increase will occur and the container may burst.

Special protective equipment for fire-fighters : Fire-fighters should wear appropriate protective equipment and self-contained breathing apparatus (SCBA) with a full face-piece operated in positive pressure mode.

Section 6. Accidental release measures

- Personal precautions** : Use suitable protective equipment (section 8). Do not allow to enter drains or watercourses.
- Environmental precautions** : Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air).
- Methods for cleaning up** : For small spills, add absorbent (soil may be used in the absence of other suitable materials), scoop up material and place in a sealable, liquid-proof container for disposal.
