HAZARDS IDENTIFICATION (ANSI Section 3)

Primary route(s) of exposure : Inhalation, skin contact, eye contact, ingestion. Effects of overexposure :

Inhalation: Irritation of respiratory tract. Prolonged inhalation may lead to mucous membrane irritation, dizziness and/or lightheadedness, headache, nausea.

Skin contact : Irritation of skin.

- Eve contact : Irritation of eyes.
- Ingestion: Ingestion may cause mouth and throat irritation, mucous membrane irritation, gastrointestinal disturbances.

Medical conditions aggravated by exposure : Eye, skin, respiratory disorders.

FIRST-AID MEASURES

(ANSI Section 4)

- Inhalation : Remove to fresh air. Restore and support continued breathing. Get emergency medical attention. Have trained person give oxygen if necessary. Get medical help for any breathing difficulty.
- Skin contact : Wash thoroughly with soap and water. If any product remains, gently rub petroleum jelly, vegetable or mineral/baby oil onto skin. Repeated applications may be needed. Remove contaminated clothing. Wash contaminated clothing before re-use.
- **Eve contact :** Flush immediately with large amounts of water, especially under lids for at least 15 minutes. If irritation or other effects persist, obtain medical treatment.

Ingestion : If swallowed, obtain medical treatment immediately.

FIRE-FIGHTING MEASURES

- Fire extinguishing media : Dry chemical or foam water fog. Carbon dioxide. Closed containers may burst if exposed to extreme heat or fire. May decompose under fire conditions emitting irritant and/or toxic gases. In closed tanks, water or foam may cause frothing or eruption.
- Fire fighting procedures : Water may be used to cool and protect exposed containers. Firefighters should use full protective clothing, eye protection, and self-contained breathing apparatus. Selfcontained breathing apparatus recommended.

Steps to be taken in case material is released or spilled : Comply with all applicable health and environmental regulations. Eliminate all sources of ignition. Ventilate area. Evacuate all unnecessary personnel. Place collected material in proper container. Large spills - shut off leak if safe to do so. Dike and contain spill. Pump to storage or salvage vessels. Use absorbent to pick up excess residue. Keep salvageable material and rinse water out of sewers and water courses. Small spills - use absorbent to pick up residue and dispose of properly.

HANDLING AND STORAGE

- Handling and storage: Store below 100f (38c). Keep away from heat, sparks and open flame. Keep from freezing.
- Other precautions: Use only with adequate ventilation. Do not take internally. Keep out of reach of children. Avoid contact with skin and eves, and breathing of vapors. Wash hands thoroughly after handling, especially before eating or smoking. Keep containers tightly closed and upright when not in use. Empty containers may contain hazardous residues.

EXPOSURE CONTROLS/PERSONAL PROTECTION (ANSI Section 8)

Respiratory protection : Control environmental concentrations below applicable exposure standards

when using this material. When respiratory protection is determined to be necessary, use a NIOSH/MSHA (Canadian z94.4) Approved elastomeric sealing- surface facepiece respirator outfitted with organic vapor cartridges and paint spray (dust/mist) prefilters. Determine the proper level of protection by conducting appropriate air monitoring. Consult 29CFR1910.134 For selection of respirators (Canadian z94.4).

Ventilation : Provide dilution ventilation or local exhaust to prevent build-up of vapors.

Personal protective equipment : Eye wash, safety shower, safety glasses or goggles. Impervious gloves, impervious clothing.

- Supplemental health information : Contains iron oxide, repeated or prolonged exposure to iron oxide dust may cause siderosis, a benign pneumoconiosis.
- **Carcinogenicity**: The international agency for research on cancer (IARC) has classified carbon black as possibly carcinogenic to humans (group 2b) based on sufficient evidence in animals and inadequate evidence in humans. In a lifetime inhalation study, exposure to 250 mg/m3 titanium dioxide resulted in the development of lung tumors in rats. These tumors occurred only at dust levels that overwhelmed the animals' lung clearance mechanisms and were different from common human lung tumors in both type and location. The relevance of these findings to humans is unknown but questionable. The international agency for research on cancer (IARC) has classified titanium dioxide as possibly carcinogenic to humans (group 2b) based on inadequate evidence of carcinogenicity in humans and sufficient evidence of carcinogenicity in experimental animals.
