4. FIRST AID MEASURES

INGESTION

Residual sealant may remain on fingers for several days and transfer to lenses and cause severe eye irritation. Product releases methanol during application and curing. Product releases ammonia during application and curing.

STORAGE

Store away from heat, sources of ignition, and incompatibles. Keep out of the reach of children.
