# 2. Hazard Identification

EMERGENCY OVERVIEW: Harmful if swallowed. Extremely flammable liquid and vapor. Vapors may cause flash fire or explosion. Contents Under Pressure. Harmful if inhaled. ## 4. First-aid Measures

# 7. Handling and Storage
