#### 2. Hazard Identification

EMERGENCY OVERVIEW: Harmful if swallowed. Causes eye irritation. Vapors irritating to eyes and respiratory tract. Combustible liquid and vapor. Harmful if inhaled. Risk of overexposure depends on duration and level of exposure to dust from repeated sanding of surfaces or spray mist and the actual concentration of Titanium Dioxide in the formula.

#### 4. First-aid Measures
