# **SECTION 4. FIRST-AID MEASURES**

#### First-aid Measures

#### Inhalation

# Eye Contact

Take care not to rinse contaminated water into the unaffected eye or onto the face. If eye irritation persists, get medical advice/attention.

#### Ingestion

# Personal Precautions, Protective Equipment, and Emergency Procedures

#### **Environmental Precautions**

### Methods and Materials for Containment and Cleaning Up

# Precautions for Safe Handling
