#### **Description of necessary first aid measures**

**Eye contact**

# Section 5. Fire-fighting measures

### **Extinguishing media**

Suitable extinguishing media

: Use dry chemical, CO<sub>2</sub>, water spray (fog) or foam.

Unsuitable extinguishing media

Specific hazards arising from the chemical

: Flammable liquid and vapor. Runoff to sewer may create fire or explosion hazard. #### **Precautions for safe handling**
