### 2. Hazard Identification

#### 4. First-aid Measures

**FIRST AID - INGESTION:** Swallowing less than an ounce will not cause significant harm. For larger amounts, do not induce vomiting, but give one or two glasses of water to drink and get medical attention. If swallowed, rinse mouth with water. If feeling unwell, get medical attention.
