## Section 2 - Hazards Identification

**Emergency Overview:** A crystal clear paste product with a slight odor. **WARNING!** May cause eye, skin, nose, throat and respiratory tract irritation. Harmful if swallowed or absorbed through the skin.

**Effects Of Overexposure - Eye Contact:** May cause eye irritation.

**Effects Of Overexposure - Skin Contact:** Harmful if absorbed through the skin. May cause skin irritation. Prolonged or repeated skin contact can result in sensitization and dermatitis.

A mixture of diisodecyl phthalate and diisononyl phthalate has been tested in a two-generation toxicity study in laboratory animals. No effects on reproductive parameters were seen. However, a small but statistically significant increase in early

offspring mortality was seen at high oral doses. The significance of this to humans is uncertain.

### Section 4 - First Aid Measures

**First Aid - Eye Contact:** In case of contact, immediately flush eyes with large quantities of water for at least 15 minutes until irritation subsides. Get medical attention immediately.
